VISITORS MAY TOUR EITHER OF COSANTI FOUNDATION'S PHYSICAL SITES TO SEE THE CONCEPTS OF ARCOLOGY REFLECTED IN FACILITIES THAT ARE ACTIVELY USED FOR BOTH RESIDENTIAL AND COMMERCIAL PURPOSES.
